<p>The Manchester & Salford Branch of the RSPCA is a separately registered charity. The role of the branch is to rehabilitate and rehome the animals that the national RSPCA charity rescues through the inspectorate service. We also offer free or low cost microchipping and neutering to people on a low income.</p> <p>We are self-funding and need to raise £600,000 each year to continue our work. The branch has five charity shops and a small fundraising programme.</p>

Hours of work	We are looking to recruit a full time (37.5 hrs per week) shop manager for our Urmston shop. Core working hours are 9.00 to 5.00 Tuesday to Saturday. You will need to be flexible about your working days/days off in the event of staff absence.
About the job	Our Urmston shop has been part of the community for over 10 years. We are seeking to recruit someone who has a passion for people, retail and animals who can continue to nurture the positive community relations we have established. The site is split on two levels and the work involves processing high volumes of incoming donations, so you must be able to cope with the physical demands of this role. There are weekly targets set for sales and Gift Aid and you must be motivated to achieve great results.
Qualities sought	You must embrace working in the heart of the local community, promoting our cause and raising much needed funds for the animals in our care. You must have a proven track record of achieving targets whilst maintaining high standards of quality and presentation. As an ambassador for the branch you must be an enthusiastic

	communicator capable of nurturing and maintaining positive relationships with customers, donors, staff and volunteers alike.
